<u>INTRO</u>

1. NARRATOR:

Hello! Glad you tuned in for this next episode of "Crossroads Generation",

our radio series about a group of young Africans and the challenges they

face in their daily lives. We're in the middle of the third season, called

"Facing the Future". Last time, the university students Mercy and Trudy

were worried about their friend Tina:

2. FLASHBACK: EPISODE 13, LINES 75-79

MERCY: We missed you in class yesterday and today. Are you okay, Tina?

TINA: I'm fine. I'll talk to you later.

SFX: CALL ENDED

MERCY: Tina, wait --

**TRUDY:** What? Did she just hang up on you?

3. NARRATOR:

Trudy and Mercy don't know what kind of work Tina does on the side. But

we'll come to that later... Mercy has some other things on her mind. The

father of her boyfriend Niki is in hospital. But when she went to see him,

Niki's mother didn't give her a friendly welcome:

## 4. FLASHBACK: EPISODE 13, LINES 104, 109-111

MRS. JUMBE: (firm) Young girl, please wait outside!

NIKI: (sighs) Mum, come on! Don't start!

SFX: FAST FOOTSTEPS AS MERCY LEAVES

**NIKI:** Wait. Mercy! Where are you going -- Wait!

MRS. JUMBE: Huh! Good riddance!

## 5. NARRATOR:

On top of all that, Mercy's family is dealing with a dark chapter in its history. Four years ago, Mercy's father sold his newborn baby to the politician Mukaraba. Now he's trying to make it right by testifying in court. This will be a big surprise for Mukaraba, who thought it was going to be easy to dismiss the case! This fourteenth episode, called "A Pain in the Neck", starts in the courtroom...

## **SCENE 1: MSOTO'S DAY IN COURT**

- 6. ATMO: COURT ATMO
- 7. LAWYER: (low voice) So, Mr. Mukaraba, are you ready for our next day in court?
- 8. MUKARABA: Of course I am. With you as my lawyer I have nothing to fear. (laughs) Besides, this whole case is ridiculous. They might as well declare me innocent right now...
- 9. JUDGE RAY: Silence in court! The prosecutor will call the first witness for today.
- **10. PROSECUTOR:** Our first witness is Mr. Msoto.
- 11. CROWD: (murmurs: "Isn't that the man who sold her?"

  "That's the father", etc.)
- 12. MUKARABA: What? I thought --
- **13. JUDGE RAY:** Silence!

#### **KW BEGIN**

- **14. CROWD**: Shame! Shame!
- 15. SFX: GAVEL HITS HARD SURFACE.
- **16. JUDGE RAY:** Silence in court!
- 17. CROWD: GOES SILENT

**18. JUDGE RAY:** This is the final warning. One more outburst like that and I will have all of you thrown out of the courtroom. Prosecutor, please proceed!

**19. PROSECUTOR:** Thank you, Your Honour. **(to Msoto)** State your name for the record.

**20.** MSOTO: My name is Msoto.

**KW END** 

FLASHBACK: Ep. 15, line 2

21. PROSECUTOR: Mr. Msoto, according to Inspector Mary, you're willing to tell us your side of the story, even if this means incriminating yourself?

**22. MSOTO:** That's right.

23. PROSECUTOR: Then please start by telling the court what your relationship with the child in this case is.

**24. MSOTO:** I am her biological father.

25. PROSECUTOR: Where were you when the baby was born?

**26. MSOTO:** At home with my wife.

**27. PROSECUTOR:** And what happened immediately after the baby was born?

**28. MSOTO:** I took her and gave her to Councillor Mukaraba.

- **29. PROSECUTOR:** Why?
- 30. MSOTO: (hesitates) That... that was the agreement. I... I knew that he wanted a child, and that he couldn't have one himself --
- 31. MUKARABA: That's nonsense! I can father as many children as I like!
- **32. JUDGE RAY:** Silence, Mr. Mukaraba! Please go on, Mr. Msoto.
- 33. MSOTO: At the time, I thought he could take care of our child better than we could. We had money problems, and we were not able at the time to take good care of her. But I regret what I did then, and King Karubu, my saviour, knows that I was misled ...
- **34. PROSECUTOR:** Did Mr. Mukaraba pay you money as part of this agreement?
- **35. MSOTO:** (hesitates) Yes, he gave me some money, but --
- **36.** MUKARABA: Some money? It was -- (falls silent)
- 37. LAWYER: (whispers to him) Mr. Mukaraba, I would advise you to be quiet now!
- **38. MUKARABA:** You're fired! What kind of lawyer are you if you didn't even know that Msoto would testify?

**39.** LAWYER: Mr. Mukaraba --

40. MUKARABA: Don't talk to me!

**41. LAWYER:** Your Honour, could we take a short break, please?

#### **SCENE 2: MERCY AND NIKI OUTSIDE THE HOSPITAL**

42. ATMO: OUTSIDE THE HOSPITAL

43. MERCY: (crying)

44. SFX: RUNNING FOOTSTEPS APPROACHING

**45. NIKI:** (as he approaches) Mercy! Mercy!

**46. MERCY: (cries)** Leave me alone, Niki.

**47. NIKI:** Mercy, I'm sorry about my mother. She can be such

a pain in the neck sometimes!

48. MERCY: (cries)

**49. NIKI:** Mercy, come on. You know what my mother's like.

She can be rude and arrogant, but she can't change

my decision to be with you.

**50. MERCY:** She hates me, Niki. What did I ever do to her?

FLASHBACK: Ep. 15, line 4

**51. NIKI:** Just ignore her, Mercy darling. I love you!

**52. MERCY:** You have a strange way of showing it. Why haven't

you been taking my calls?

**KW BEGIN** 

**53. NIKI:** I sent you a text, didn't !?

**54. MERCY:** 'My father sick in hospital', that's what you wrote.

But that doesn't explain why you don't pick up when

I call, or why you haven't called me back!

**55. NIKI:** Mercy, I... I'm just confused. I don't know how to

deal with... with --

**56. MERCY:** With my daughter Linda. Just say it!

**57.** NIKI: (stammers) |... |...

**58. MERCY:** That's what I thought!

**KW END** 

**59. NIKI:** Mercy, I --

**60. MERCY:** You've been avoiding me ever since I brought my

daughter to live with me.

**61. NIKI:** It's not like that...

**62. MERCY:** I always knew your mother didn't like us being

together, and that she hates the fact I have a child

who isn't yours... But I thought that was just her!

63. NIKI: SILENT

**64. MERCY:** Oh, great. Goodbye, Niki.

**65. NIKI:** Mercy...

66. SFX: FOOTSTEPS AS MERCY LEAVES

# **SCENE 3: TINA AND MERCY ON THE ROAD**

67. ATMO: ON THE STREET

68. SFX: CAR APPROACHING

69. SFX: CAR HOOTING

**70. MERCY:** (still sad, to herself) Stupid car drivers... Leave

me alone!

**71. TINA:** (shouts, from the car) Hey, Mercy! It's me, you

idiot!

**72. MERCY:** (surprised) Oh, Tina! Sorry, I thought it was --

**73. TINA:** (interrupts) -- some old guy trying to seduce you

from his car? Mercy, you're so stubborn! (laughs)

...Hey, what's up? You look sad...

**74. MERCY:** I just had a fight with Niki.

FLASHBACK: Ep. 15, line 6

**75. TINA:** Sorry to hear that... Hey, Mercy, listen. I'm sorry I

was abrupt on the phone last time you called. It

wasn't a good time. How about I make it up to you

and take you out for a drink tonight? We can drive

around in this nice car... (laughs)

**KW BEGIN** 

**76. MERCY:** I didn't even know you knew how to drive! Whose

car is it? It's nice!

**77. TINA:** Well, it's mine!

**78. MERCY:** (surprised) Whaat? When did you -- how did you --

Where did you get the money to buy such an

expensive car?

**79. TINA:** (laughs) You actually believed me? No: it belongs

to a friend.

**KW END** 

**80. MERCY:** Tina, I don't know. I have a lot of catching up to

do... And I don't feel like --

**81. TINA:** Come on – it'll take your mind off that fight with Niki

and everything. (convincingly) Hey, I might even

let you drive!

**82. MERCY:** But I don't know how to drive!

**83.** TINA: Oh, it's easy! I'll show you...

**84. MERCY:** I don't know...

**85. TINA:** Well, I'm not forcing you. Just thought it could be

fun... I'll pick you up tonight, okay?

**86. MERCY:** Aren't you going to class?

**87. TINA:** Next time. I have something else to do right now.

88. MERCY: But, Tina --

**89. TINA:** See you later!

90. SFX: CAR DRIVES OFF

## **SCENE 4: MUKARABA IS ANGRY WITH MSOTO**

91. ATMO: IN THE BROTHEL, CLUB MUSIC IN THE

**BACKGROUND** 

**92. MNENE**: **(to himself)** I have to count today's takings before

Mukaraba comes bursting in...

93. SFX: DOOR OPENS

94. SFX: FOOTSTEPS STOMP IN

**95. MNENE:** Oh, hi, Boss. How was your --

**96. MUKARABA:** (interrupts angrily) Who the hell does this Msoto

think he is? Doesn't he know who I am? DAMN! He

should know better by now!

**97. MNENE:** Easy, Boss. What happened?

98. MUKARABA: That pain in the neck showed up in court as a

witness. Can you believe it? The fool has turned

against me! After I warned him again and again...

#### **KW BEGIN**

**99. MNENE:** That's pretty stupid of him. I mean, he's the one

who sold the baby to you! He's just implicating

himself.

**100. MUKARABA:** That's the thing – he did it anyway! I'm still trying to

understand why. Maybe this Inspector Mary has

offered him a deal or something.

**KW END** 

**101. MNENE:** Then offer him money. Money always works magic,

especially if someone loves the bottle like he does.

**102. MUKARABA:** You think I haven't tried that? I don't think it'll work

any longer... Apparently he's now a servant of the

mighty King Karubu, whoever that may be... No, I

think I need to try something different.

**103. MNENE:** King Who? (laughs) Sorry, Boss. (pause) I think

you should talk to the judge. You're a respected

leader, after all. People listen to you – especially

when you come bearing gifts.

**104. MUKARABA:** Wait – are you suggesting I bribe the judge?

**105. MNENE:** Exactly!

106. MUKARABA: Good idea. (pause) Except that YOU will do it,

Mnene!

**KW BEGIN** 

**107. MNENE:** (shocked) What? Why me?

108. MUKARABA: Because I say so. Why do you think I pay you so

much money?

**109. MNENE:** But... but...

**110. MUKARABA:** No buts! You will approach the judge on my behalf

and make the payment.

**KW END** 

**111. MNENE:** Boss... I think --

**112. MUKARABA:** I don't pay you to think, Mnene. You will do as I say,

and that's that.

113. MNENE: (sighs)
